This is a blank annotated template. It carries no certificate number, issuer stamp or signature and has no legal value. Only an accredited Islamic certification body recognised by the destination authority may issue a real halal certificate.

must match the shipping documents

CONTAINER AND SEAL NUMBERS

one line per container, list on annex if needed

4. PRODUCT COVERED BY THIS CERTIFICATE

Product description	Lot / production code	Cartons	Net weight (kg)

Lot codes here must match the packing list exactly. A mismatch between lot codes and the certificate is the most frequent cause of consignments being held at the destination port.

5. HALAL DECLARATION

The certification body declares that the animals covered above were slaughtered by a Muslim slaughterman in accordance with Islamic requirements and the standard named in section 1; that no prohibited substance, additive or processing aid was used; and that the product was fully segregated from non-halal product throughout slaughter,
